Who owns Drax Power Station?

In 1990, the electricity industry of England and Wales was privatised under the Electricity Act 1989. Three generating companies and 12 regional electricity companies were created. As a result of privatisation, Drax Power Station came under the ownership of National Power, one of the newly formed generating companies.

What happened to Drax Power Station?

One significant change was the emergence of vertically integrated companies, combining generation, distribution and supply interests. In certain cases, it became necessary for generation assets to be divested, and so in 1999 Drax Power Station was acquired by the US-based AES Corporation for £1.87 billion (US\$3 billion).

When does Drax Power Station start generating electricity?

The Selby coalfield is discovered and the Central Electricity Generating Board begins building Drax Power Station to use its coal. Two other recently-built coal power stations, Ferrybridge C and Eggborough, begin generating electricity. Drax Power Station begins generating electricity after its first 660MW unit is commissioned.

When did Drax Group acquire Haven Power & Billington Bioenergy?

In 2009,Drax Group acquired Haven Power - enabling it to sell electricity directly. In 2015,the Group acquired Billington Bioenergy,specialists in providing sustainable biomass pellets for domestic energy systems.

Is Drax power station compliant with LCPD?

Drax Power Station undergoes refinancing and Drax Group plc is listed on the London Stock Exchange. Boosted-over-fire-air (BOFA) technology is retrofitted to all boilers and emissions of nitrous oxide (NO X) are reduced ensuring Drax Power Station is compliantwith a strengthened Large Combustion Plant Directive (LCPD).

What happened to AES & Drax Power Station?

AES and Drax part waysafter one of the power station's major customers goes into administration. As creditors, various financial institutions take control of Drax Power Station. Drax Power Station undergoes refinancing and Drax Group plc is listed on the London Stock Exchange.
