When was the British Indian Ocean Territory established?

Formerly administered as part of the British Crown Colony of Mauritius, the British Indian Ocean Territory (BIOT) was established as an overseas territory of the UK in 1965. A number of the islands in the territory were later transferred to the Seychelles when it gained independence in 1976.

What is British Indian Ocean territory (Biot)?

The British Indian Ocean Territory (BIOT) was formed on 8th November 1965. It is one of 14 British Overseas Territories. There is no permanent population in BIOT, but Diego Garcia, the largest of the 58 islands hosts a joint UK-US military facility.

When did the Chagos Islands become part of the British Indian Ocean territory?

The islands were constituted as the British Indian Ocean Territory in 1965by an Order in Council under the Royal Prerogative. This comprises all the islands of the Chagos Archipelago and until June 1976 also included the islands of Aldabra,Desroches and Farquhar which were then ceded to the Seychelles,of which they are now part.

What is the British Indian Ocean territory (Constitution) Order 2004?

The British Indian Ocean Territory (Constitution) Order 2004 defines the territory as comprising the following islands or groups of islands: These islands and associated coral reefs lie between 4°44 and 7°41 south and 70°47 and 72°47 east.

How many islands are in the British Indian Ocean territory?

Map of the British Indian Ocean Territory since 1976. The territory is an archipelago of 58 islandscovering 56 square kilometres (22 sq mi). The largest island is Diego Garcia, which at 32.5 square kilometres (12.5 sq mi) accounts for about half of the territory's total land area.

The post is currently held by Commander Roger Malone. The constitutional arrangements for BIOT are set out in the British Indian Ocean Territory (Constitution) Order 2004 and related instruments. With some uncertainty about inclusion and ownership, Diego Garcia was finally solidified as an entity with the creation of the British Indian Ocean Territory (BIOT) in 1965. ...
