Therefore, as Amanda said, fossil fuels -- including imported coal and natural gas -- generate nearly 85% of Taiwan's electricity. To counter these obstacles, companies can play a crucial role in developing new strategies to increase renewable energy supplies and promote emerging technologies.

How much green energy has been sold through the T-Rec program?

More than 700 million kWh of green energy had been sold through the T-REC program as of November 2020, surpassing government expectations according to the Bureau of Standards, Metrology, and Inspection at the Ministry of Economic Affairs (MOEA). The latest batch of T-RECs also brought onshore wind into the fold.

What is Taiwan's energy mix?

Taiwan is also targeting an energy mix of 20% renewables, 50% natural gas, and 30% coal by 2025 - a substantial reduction for the role of coal in Taiwan power generation, and with Liquid Natural Gas (LNG) the most significant and growing source in Taiwan's energy mix.

Does Taiwan have a carbon-free energy goal?

Since then, Taiwan has achieved a significant cumulative contracted capacity through corporate PPAs, becoming one of the leading corporate PPA markets in the Asia-Pacific region. Continued progress on our carbon-free energy goal is happening across Asia Pacific with recent announcements in Australia and Japan.

Can Taiwan become a green energy hub?

But as the sector matures and a green energy ecosystem is catalyzed, Taiwan can reformulate its approach to promote national techno-economic competitiveness and to differentiate itself as a cut above the rest.
