

Photovoltaic support project cooperation agreement

Why is the photovoltaics agreement important?

The Agreement we signed today is an important signal determining the direction of future actions. Photovoltaics is one of the key sectors for both the power industry and our economy as a whole. In recent years, we have seen its dynamics and increasing importance in formation of our energy market.

How does the EU support the European solar PV manufacturing sector?

Over the last years, the EU has taken initiatives to strengthen its support to the European solar PV manufacturing sector, which includes several globally competitive companies in several steps of the value chain.

What is the EU photovoltaic charter?

Signed today in the margins of the informal Energy Council meeting by the Commission - represented by EU Commissioner for Energy Kadri Simson - energy ministers from 23 EU countries and industry representatives, the charter sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.

What are collective solar energy projects?

Collective solar energy projects provide another avenue to reduce the consumption of fossil fuels and address energy poverty and vulnerability. Current legislation already supports renewable and citizen energy communities, as well as collective solar initiatives to generate, store, share, exchange, and use energy.

How can Europe support cross-border cooperation on solar energy projects?

Other instruments are contributing to this effort: the cohesion policy funds, InvestEU, the Innovation Fund, the Modernisation Fund, Horizon Europe and the LIFE programme. Connecting Europe Facility RES and the EU renewable energy financing mechanism will support cross-border cooperation on solar energy projects.

When will the European Solar charter be implemented?

One year following the signature of the Charter, the Commission will review the implementation of the adopted commitments. The European Solar Charter, signed on 15 April 2024, sets out a series of voluntary actions to be undertaken to support the EU photovoltaic sector.
