What is La Réunion's energy strategy?

In March 2019,La Réunion's Regional Council revised and approved the island's energy strategy,the Multiannual Energy Program(PPE) set up by the Energy Transition Law for Green Growth of August 2015,defining the island's objectives in terms of energy production and management by 2023 and 2028.

How does La Réunion achieve energy autonomy?

Electricity is produced by coal for 36% and heavy fuel oil and diesel for 33%. To limit its heavy dependence on imported fossil fuels, La Ré union aims to achieve energy autonomy by 2030 based on greater energy efficiency and renewable energy alternatives (50% renewable electricity by 2020, and 100% by 2030).

How much energy does La Réunion use?

Like most overseas territories,La Réunion is heavily dependent on imported fossil fuels. Of the 1,491 thousand metric tonsof oil equivalent of primary energy consumption in 2019,1,305 thousand tons of oil equivalent were imported,72% of which were oil and gas and 28% coal. Originating from South Africa,this coal is used to generate power.
