

# The solar power generation manufacturer went bankrupt

How did SunPower's bankruptcy affect the solar industry?

Even before the bankruptcy filing, SunPower ceased solar lease and PPA offerings, creating problems that reverberated through the industry. The effects trickled down to dealers and installers like Renova Energy, a major SunPower partner that services the Nevada and California markets and maintains an excellent 4.9-star rating on SolarReviews.

### Why did SunPower file for bankruptcy?

SunPower filed for Chapter 11 bankruptcy late Monday after announcing plans to sell portions of its operations to Complete Solariafor \$45 million. One of the largest residential solar installation companies in the U.S.,SunPower was a leading U.S. manufacturer of solar panels before it spun out its manufacturing operations in 2019.

### Is SunPower bankruptcy a reorganization?

The first thing to know about the SunPower bankruptcy is that it's a Chapter 11(or reorganization) bankruptcy, which is quite different from a Chapter 7 (or liquidation) bankruptcy.

## Did a bankruptcy judge approve a \$45 million bid for SunPower?

REUTERS/Peter DaSilva Purchase Licensing Rights Aug 29 (Reuters) - A U.S. bankruptcy court judge approved on Thursday a \$45 million bidfor the assets of failed residential solar company SunPower by rival Complete Solaria.

#### Will SunPower restructure its business assets?

It's unclearwhether SunPower will seek to retain and restructure any of its business assets. As part of the reorganization, SunPower entered into an Asset Purchase Agreement (APA) with Complete Solaria, a residential solar EPC (engineering, procurement, and construction) company based in California.

#### How much debt does SunPower have?

The bankruptcy documents indicate that SunPower has approximately \$2.01 billionin outstanding debt obligations. SunPower has entered into an agreement to sell its Blue Raven and New Homes business units, along with a portion of its dealer network, for \$45 million in cash to Complete Solaria as a so-called "stalking horse" bidder.
