Will Santos bury carbon dioxide under ageing gas fields in Timor-Leste?

Australian energy giant Santos has signed a dealwith Timor-Leste authorities to advance a project designed to bury carbon dioxide beneath ageing gas fields in the Timor Sea.

Who owns the Bayu-Undan gas & condensate field in Timor-Leste?

The Santos-led owners of the Bayu-Undan gas and condensate field offshore the Timor Sea have signed an agreement with the Timor-Leste petroleum regulator to progress carbon capture and storage at the field.

What are the barriers to the CCS project offshore East Timor?

Robertson said there were several barriers to the CCS project offshore East Timor, also known as Timor Leste, proceeding. Including, firstly, a long and expensive pipeline will need to be built to ship the carbon dioxide (CO2) from Barossa or the LNG facility in Darwin, northern Australia, to Bayu Undan.

Does Timor-Leste have jurisdiction over the Bayu-Undan oil pipeline?

As per the treaty, Timor-Leste has sole jurisdiction over the Bayu-Undan upstream facilities and contract area, the export pipeline from Bayu-Undan to Darwin LPG falls under Australia's jurisdiction. The Bayu-Undan field produced 114,000 barrels of oil equivalent a day (boed) in 2019.

Is Timor-Leste a carbon free country?

Soares said that despite Timor-Leste being one of the lowest emission countries in the worldand that the Paris Agreement provides waiver or concession to the developing and less developed nation such as Timor-Leste: "We understand that carbon trading or carbon credit market is an integral part of our future economy."

The Bayu-Undan is a shallow-water field located in 80m-deep waters, approximately 250km southeast off the coast of Suai, Timor-Leste, in the Timor Sea. The field is situated approximately 500km northwest off the coast of Darwin, Australia.

Santos has plans to collaborate with Timor-Leste and the JV partners to repurpose the Bayu-Undan site into a major commercial carbon capture and storage project after the cessation of petroleum production.
