Can US companies do business in Syria?

Treasury Department rules prohibit most U.S. companies from doing business in Syria. The waiver for Delta Crescent Energy was issued in April 2020, months after Trump announced that he wanted to keep some U.S. troops in the oil-rich region to maintain control of the oil profits.

Will the US invest in Syria's oil?

Stabilization efforts Ahed al-Hendi, a Syrian affairs analyst based in Washington, said the oil deal will improve the lives of Syrians living in the northeast and that the U.S. decision to invest in Syria's oil is part of its post-IS stabilization efforts.

How much oil does Syria produce a day?

**Prior to sanctions, Syria produced some 383,000 barrels per day(bpd) of oil and liquids, according to previous analysis by the U.S. Energy Information Administration (EIA). **Oil and liquid production fell to 40,000 bpd in 2023, according to separate estimates from the Energy Institute.

What happened to Syria's oil & natural gas industry?

Syria, previously the eastern Mediterranean's leading oil and natural gas producer, has seen its production fallto a fraction of pre-conflict levels. Syria is no longer able to export oil, and as a result, government revenues from the energy sector have fallen significantly.

Who owns Syria's natural gas?

The Syrian Gas Company (SGC)--which fell under the GPC--was the key entity in Syria's upstream natural gas operations, a position it inherited after being split off from the SPC in 2003. Syria's natural gas distribution network was managed by the SCOT.

Does Iran supply oil to Syria?

It is likely that Iran continues to supply Syria with crude oil and refined products.3 Oil theft is also a problem, with Syrian officials claiming that hundreds of barrels of crude oil are being stolen and shipped to neighboring countries each day.
